INTRODUCTION



This is the official Nebraska Seed Potato Directory of the Potato Certification Association of Nebraska (PCAN) for the 2025 crop year. The Potato Certification Association of Nebraska (PCAN) is a not-for-profit organization and official designated agency of the University of Nebraska-Lincoln. The lots listed in this directory are those that have passed, at minimum, two summer field inspections. The following are required for a lot to be considered certified within the state of Nebraska:

- Originate from planting stocks that were grown in a sterile environment and underwent proper disease testing.
- Pass both summer field inspections. The potato seed stocks on this list represent all seed fields which have passed field inspections and are within the tolerance for diseases and mixtures.
- Pass a post-harvest test. PCAN conducts post-harvest tests in one of three ways:
 - A grow out. Samples are grown out in a warm location sometime between November and January and are visually inspected for the presence of PVY, PLRV or other diseases. ELISA tests are conducted on these lots for PVY and PLRV at the request of the grower. If no laboratory test is conducted as part of the grow out, this will be indicated on the North American Plant Health Certificate with an NT (no-test) designation.
 - In a greenhouse. Samples are planted in a greenhouse close to the PCAN office, and not offsite at a warm location. Visual inspections and laboratory testing are conducted the exact same way as in a traditional grow out.
 - Laboratory Testing. In the case of sprout testing, samples are allowed to sprout and ELISA tests are conducted on the sprouts. This is the preferred method for varieties with long dormancy. For Field Year 3 or higher lots that are remaining in Nebraska or not being sold as seed, direct tuber testing PCR testing may be utilized in place of vine or sprout ELISA with PCAN approval.
- Eligible seed lots shall be sampled for a winter test and be approved before replanting as certified seed potatoes in Nebraska.
- Pass a state shipping point inspection.
- Adhere to all the requirements with the Rules and Regulations of the Potato Certification Association of Nebraska. These Rules and Regulations can be found at the official website of the Potato Certification Association of Nebraska: www.nebraskapotatoes.com.

POTATO CERTIFICATION ASSOCIATION OF NEBRASKA STAFF, EXECUTIVE COUNCIL, AND ADVISORY COMMITTEE

Purpose

The Potato Certification Association of Nebraska (PCAN) is a non-profit, non-stock corporation which conducts inspection and certification of potatoes, when authorized by the College of Agriculture of the University of Nebraska in pursuant to sections 81-2, 149 to 81-2, 154 (Reissue Revised Statutes of Nebraska 1943). The agency was designed to encourage the production of potatoes and other crops for seed purposes in the states of Nebraska and Wyoming.

Structure

In 1931 the Vice Chancellor of the Institute of Agriculture and Natural Resources at the University of Nebraska, under State Law, House Roll 67, designated PCAN as a potato certification agency. Under the law of Nebraska, PCAN was incorporated on June 4, 1951. The Vice Chancellor (with an Advisory Committee), specifies the Standards for Certification, and approves rules and procedures used by the certifying agency. The Advisory Committee is composed of the department heads of Agronomy and Horticulture, Entomology, and Plant Pathology with the Associate Dean of Agriculture Research serving as chairperson.

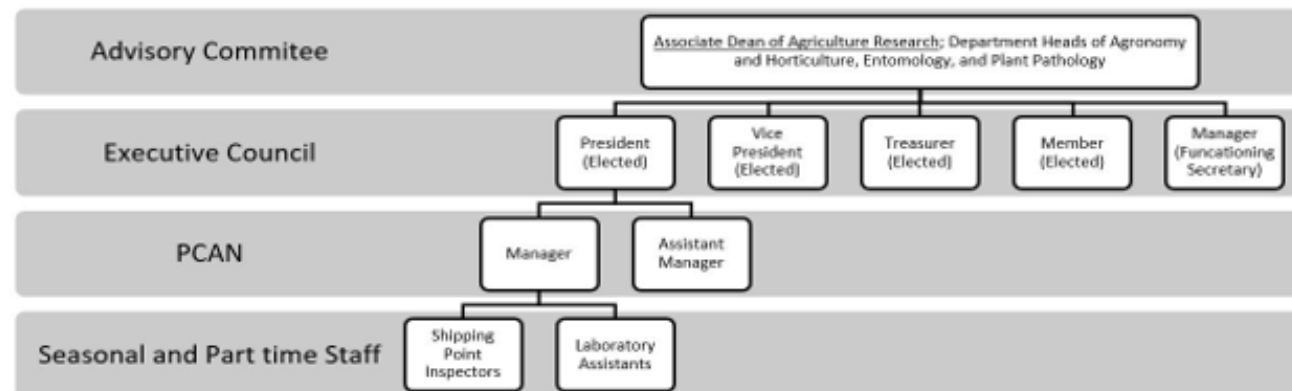


Figure 1. Nebraska Potato Certification structure

The Executive Council of PCAN is responsible for financing and administering the regulations and for establishing proper conduct of potato seed certification in the states of Nebraska and Wyoming. The Executive Council consists of four active members who are elected at the Association's Annual meeting. The manager of PCAN also sits on the Executive Council and serves as the Council's secretary. A full-time staff, consisting of a Manager and Assistant Manager, is overseen by the Executive Council to conduct day-to-day operations for the agency. These duties include, but are not limited to: field inspections, shipping point inspections, laboratory activities, post-harvest winter tests, representing the agency at professional meetings and promoting Nebraska-raised seed potatoes. The manager and assistant manager of PCAN also provide leadership and assistance to seasonal and part time staff. The structure of Nebraska Potato Certification is detailed in Figure 1.

History

Nebraska began seed potato certification in Nebraska in 1918, through the University of Nebraska–Lincoln (UNL). Nebraska growers at that time were facing many issues with the deterioration of seed in field and storage. In order to combat this Dr. H.O. Warner was hired as a potato extension specialist by UNL. His first course of action was the creation of the state's first seed potato certification program.

By the early 1920's seed potato certification was turned over to the Foundation Seed Division of the Nebraska Certified Potato Growers Association (NCPGA) (Figure 2). Seed certification was then conducted by NCPGA with UNL oversight. Since NCPGA was created for marketing purposes, many felt a new agency should be established to conduct certification only. In 1952 the Potato Certification Association of Nebraska (PCAN) was incorporated as a non-stock, non-profit association. An Executive Council is elected annually from industry members and all rule changes are approved by the Seed Certification Committee at UNL.

FIELD INSPECTIONS

Field inspections are important for any certification program because some diseases are more identifiable on the plant than on the tubers. This is the case with many strains of potato virus y (PVY), as well as potato leaf roll virus (PLRV). Furthermore, all lots considered for certification or re-certification by PCAN must be inspected during the plant growth stage (Figure 3).

A minimum of two field inspections are conducted annually by PCAN. First inspections are made in June or July, once plants are capable of exhibiting symptoms. The following two inspections occur later in summer. This allows time for inspectors to identify problems not seen earlier in the season, including varietal mixtures.

SHIPPING POINT INSPECTIONS

Shipping point inspections in Nebraska are voluntary, fee-for service inspections that have been administered by PCAN since 1952. The objective of this program is to facilitate trade by providing buyers and sellers of seed potatoes impartial and accurate information regarding quality and condition of seed potato shipments. This information is necessary to satisfy the requirements of state and federal marketing orders, or to verify compliance with specifications in a contract. These inspections are usually performed at the same time seed is being graded, but only after passing field inspections. Scoring to determine grade of these shipments is based on the United States Standards for Grades of Potatoes. The following grades are used by PCAN:

Blue Tag Grade

This grade is considered the same as the U.S. #1 Seed Potato Grade. These consist of unwashed potatoes identified as certified seed by the state of origin by blue tags fixed to the containers or official state or federal-state certificates accompanying bulk loads, which identify the crop year, grower, variety and generation, as well as the state certification agency.

Yellow Tag Grade

These are also unwashed potatoes that have not met Blue Tag tolerances for internal defects and certain diseases yet remain certified according to the Rules and Regulations of PCAN. The tagging procedure for the Yellow Grade is the same as the Blue Grade.

Green Tag Grade

This grade is intended as a buyer/seller agreement with no size or grade restrictions. Visual inspection will be performed for Bacterial Ring Rot only. The seed should not be washed and should be tagged the same way as Blue and Yellow Grade shipments.
